- DATES:** **Match Date: Sunday May 18, 2025.** The Range will be available for Practice all Day on the 13<sup>th</sup> thru 17<sup>th</sup> between 10am and 4pm. There will be a \$10.00 fee charged for range use per day. Targets will be available for sale on practice day.

- REGISTRATION:** BY MAIL
- DIRECTIONS:** On I-70 take the Bates City exit, go south on Z Highway 7.6 miles to HH Highway go East and at 1.2 miles go right on Ricky Road approx. 1.1 miles, turn right through gate. Or from 50 Highway take Z Highway North 3.5 miles to HH Highway go East and at 1.2 miles go right on Ricky Road right approx. 1.1 miles, turn right through gate.
- RULES:** Unless otherwise indicated 2025 CMP Action Pistol Rules and All Changes apply.
- TARGETS:** NRA-AP-1
- ENTRY FEE:** Entries received by May 1<sup>st</sup> will be \$140.00, post entries will be \$160.00 until entries close at 9am, May 18<sup>th</sup> 2025. Juniors \$50.00  
  
CMP or NRA Classification cards will be checked.
- ENTRY LIMIT:** First 100 Paid Entries (excluding Range Officers).
- SCHEDULE:** Competitor check in:  
Friday May 16<sup>th</sup>, 11am to 4pm  
Saturday May 17<sup>th</sup>, 12pm to 4pm  
Squadding information will be picked up at this time.  
  
Competitors briefing will begin 8:00am on May 18<sup>th</sup>, Match will commence after meeting. All competitors must attend.
- FIRING STARTS:** Range Officers will fire on Friday or Saturday May 16<sup>th</sup> & 17<sup>th</sup>, 2025.

- CHALLENGES:** There will be a \$10.00 cash challenge fee. **NO PLUG GAUGES WILL BE USED** except by an **Official Referee**. The Official Referees decision is final. If no Official Referee is available, then a 3-person jury will be selected & they will have the final decision.
- CLASSIFICATIONS:** CMP or NRA Classification System (you must have a valid NRA Action Pistol Classification card or TEMPORARY CLASSIFICATION book or you will Shoot in Master Class or Unclassified).
- MATCH SCHEDULE & CONDITIONS:** Match 1 Practical, Match 2 Barricades, Match 3 Moving Target Modified, Match 4 Falling Plates, Match 5 Regional Championship: An aggregate of scores fired in Matches 1, 2, 3, & 4. All pistols and gear must meet NRA Specifications & Power Factors (at least 9mm and have a power factor of at least 120,000 velocity x bullet weight). We will pull ammo to chronograph. You should bring at least 100 rounds of ammo to each event in case of a refire.
- RANGE RULES:** There will be no handling of firearms unless instructed so by a Range Officer. There will be a designated safe area if cleaning or repair is needed but no live ammo will be allowed in this area. Violation of this rule will result in **Disqualification**. **No** Holster test will be performed; **A Dropped Loaded Gun** will result in **Disqualification**. **Ear and Eye protection is required on all ranges**.
- GENERAL INFO:** Food will be provided on match day. We have restrooms & showers & camping facilities at the range. **No Alcoholic Beverages** are allowed on the property.
